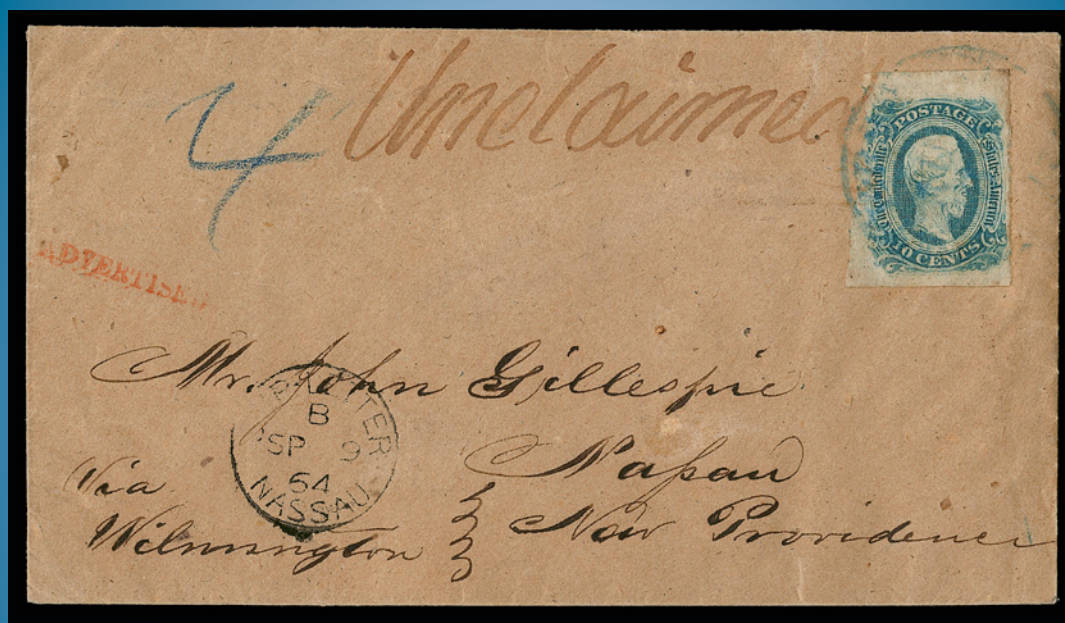

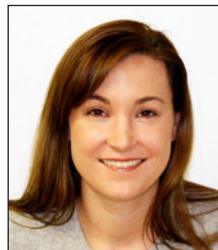

Information for Bidders

Bidding

The following means are available for placing bids:

- 1) **Attending the Live Auction in Person:** All bidders must register for a paddle, and new bidders must provide references at least three business days in advance of the sale.
- 2) **Live Internet Bidding:** Instructions for participating as a Live Internet Bidder are provided on the page opposite.
- 3) **Phone Bidding:** Bidders can be connected to the sale by phone and bid through a member of staff. Requests for phone bidding are subject to approval (please contact our office at least 24 hours before the sale). A signed Bid Form is required.
- 4) **Absentee Bids.** All bids received in advance of the sale, either by mail, fax, phone, e-mail or internet, are Absentee Bids, which instruct the auctioneer to bid up to a specific amount on one or more lots in the sale. Absentee Bids sent by phone, fax or e-mail should arrive at least one hour prior to the start of the sale session. Bids entered through Live Internet Bidding will be visible to the auctioneer during the sale. Written bids should be entered legibly on the Bid Form in the sale catalogue. E-mail and internet bids should be carefully typed and double-checked. All new bidders must provide references. We recommend calling or e-mailing to confirm that Absentee Bids sent by mail, fax or e-mail have been received and entered.

Pre-Sale Viewing

Subject to availability, certain lots (except group lots) can be sent to known clients for examination. Requests must be made no later than 7 days prior to the sale. Lots must be returned on the day received. Postage/insurance costs will be invoiced.

In addition to regular viewing, clients may view lots by appointment. Our staff will be pleased to answer questions or provide additional information about lots.

Expert Certification

Individual items offered without a current certificate (PF dated within the past five years of sale; PSE dated January 2004 or later) may be purchased subject to independent certification of genuineness and our description. **Please refer to the Conditions of Sale and Grading Terms for policies governing certification.**

Shipping and Delivery

Procedures and charges for shipping lots are printed on the back of the Bid Form. **Bidders are responsible for all prescribed shipping charges and any applicable sales tax or customs duties.**

Price Realized

Prices realized are sent with each invoice. Bidders with e-mail will receive a Bid Results report after the sale. Session results are posted immediately to siegelauctions.com

Live Internet Bidding at Siegel Auctions



Bidding from your computer lets you be part of the live auction from anywhere in the world!

There's no substitute for following the auction in real time. Live Internet Bidding lets you bid and buy as though you were right there in the saleroom.

And it's easy. Just start by following the simple steps to become a registered Live Internet Bidder. Once you've been approved for bidding, you can listen to the auction and place bids with the click of a mouse.

This step-by-step guide will instruct you how to register, set your browser and use the bidding interface.

1 Registering with Stamp Auction Network and Siegel Auction Galleries

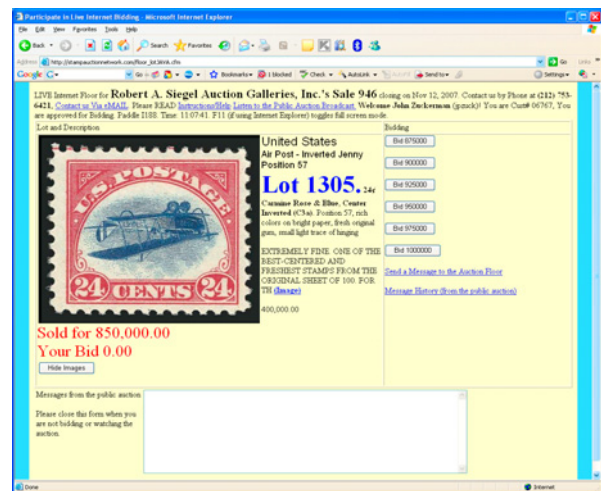
Live Internet Bidding is managed by Stamp Auction Network (SAN). To bid, you must be registered and approved by *both* SAN and Siegel. To decide what you need to do, choose the description below that best fits you.

I've already registered with SAN and have been approved by Siegel for internet bidding. You're ready for Step 2.

I've never registered with SAN, but I'm a Siegel client. Go to stampauctionnetwork.com/siegel and click on "Register" at the top. Check the box for Robert A. Siegel Auction Galleries (under "R") and submit the form, indicating you are a Siegel client. Once registered at SAN, you're ready for Step 2.

I've never registered with SAN, and this is the first time I've bid with Siegel. Go to stampauctionnetwork.com/siegel and click on "Register" at the top. Check the box for Robert A. Siegel Auction Galleries (under "R") and submit the form **with your trade references** (please, no family members or credit card companies as references). Once registered at SAN and approved by Siegel for bidding, you're ready for Step 2.

I've bid through SAN before, but this is the first time I've bid in a Siegel sale. Then you just need to be approved by Siegel. Go to stampauctionnetwork.com/siegel and click on "Update Registration" at the top. Your SAN account information will be sent to us for approval (you might be asked for other trade references). Once approved by Siegel for bidding, you can move to Step 2.



2 Using your browser for Live Internet Bidding and understanding the way it works.

Live Internet Bidding works by providing an audio feed of the auction (for anyone using Internet Explorer) and by allowing registered bidders to observe and place bids. The bidding interface shows a photo and description of the lot, the current bid (and your bidding status), and options for placing competitive bids. To join the auction, go to stampauctionnetwork.com/siegel. You can also log on at siegelauctions.com

The visual interface will work with any browser on both PC and Mac operating systems. However, the audio feed only works with Internet Explorer on a PC with ActiveX software installed. If ActiveX is not on your computer, you will have the option to install it.

Before bidding by internet for the first time, we recommend finding a sale in progress and listening to the public broadcast or logging in as a registered bidder. This will help you develop a feel for the sale tempo and bidding interface.

"System down" or "lost connection" events do occasionally happen. If you have any problems with Live Internet Bidding, please call 212-753-6421 for immediate assistance.



3 Using Live Internet Bidding to bid, track results and communicate with the auctioneer.

When you're logged on as a Live Internet Bidder, the screen will display buttons with bid increments. After you click on a bid amount, the auctioneer is immediately notified of your bid. Retracting a bid is usually not acceptable, so please bid carefully.

If you bid, then decide to stop, please use the "Pass" button, which appears once you've started bidding. This tells the auctioneer not to wait for another bid from you.

You can send messages to the auctioneer (for example, a request for extension). You can also track prior realizations from the bidding screen.

Conditions of Sale (please read carefully before bidding)

The property described in this catalogue will be offered at public auction by Robert A. Siegel Auction Galleries, Inc. ("Galleries") on behalf of various consignors and itself or affiliated companies. By bidding on any lot, whether directly or by or through an agent, in person, or by telephone, facsimile or any other means, the bidder acknowledges and agrees to all of the following Conditions of Sale.

1. The highest bidder acknowledged by the auctioneer shall be the buyer. The term "final bid" means the last bid acknowledged by the auctioneer, which is normally the highest bid offered. **The purchase price payable by the buyer will be the sum of the final bid and a commission of 15% of the final bid ("buyer's premium"), together with any sales tax, use tax or customs duties due on the sale.**
2. The auctioneer has the right to reject any bid, to advance the bidding at his discretion and, in the event of a dispute between bidders, to determine the successful bidder, to continue the bidding or to reoffer and resell the lot in dispute. The Galleries' record of the final sale shall be conclusive.
3. All bids are per numbered lot in the catalogue unless otherwise announced by the auctioneer at the time of sale. The right is reserved to group two or more lots, to withdraw any lot or lots from the sale, or to act on behalf of the seller. The Galleries will execute bidding instructions on behalf of clients, but will not be responsible for the failure to execute such bids or for any errors in the execution of such bids.
4. **Lots with numbers followed by the symbol ° are offered subject to a confidential minimum bid ("reserve"), below which the lot will not be sold. The absence of the symbol ° means that the lot is offered without a reserve. If there is no reserve, the auctioneer has sole discretion to establish a minimum opening bid and may refuse an offer of less than half of the published estimate. Any lot that does not reach its reserve or opening bid requested by the auctioneer will be announced as "passed" and excluded from the prices realized lists after the sale. The Galleries may have a direct or indirect ownership interest in any or all lots in the sale resulting from an advance of monies or goods-in-trade or a guarantee of minimum net proceeds made by the Galleries to the seller.**
5. Subject to the exclusions listed in 5(A), the Galleries will accept the return of lots which have been misidentified or which have obvious faults that were present when the lot was in the Galleries' custody, but not so noted in the lot description. **All disputed lots must be received by the Galleries intact with the original packing material within 5 days of delivery to the buyer but no later than 30 days from the sale date. (5A) EXCLUSIONS:** The following lots may not be returned for any reason: lots containing 10 or more items; lots from buyers who registered for the pre-sale exhibition or received lots by postal viewing, thereby having had the opportunity to inspect them before the sale; any lot described with "faults," "defects" or a specific fault may not be returned because of any secondary fault. Photographed lots may not be returned because of centering, margins, short/nibbed perforations or other factors shown in the illustrations. Lots may not be returned for any of the following reasons: the color of the item does not match the color reproduction in the sale catalogue or website listing; the description contains inaccurate information about the quantity known or reported; or a certification service grades a stamp lower than the grade stated in the description.
6. Successful bidders, unless they have established credit with the Galleries prior to the sale, must make payment in full before the lots will be delivered. Buyers not known to the Galleries must make payment in full within 3 days from the date of sale. **The Galleries retains the right to demand a cash deposit from anyone prior to bidder registration and/or to demand payment at the time the lot is knocked down to the highest bidder, for any reason whatsoever.** In the event that any buyer refuses or fails to make payment in cash

for any lot at the time it is knocked down to him, the auctioneer reserves the right to reoffer the lot immediately for sale to the highest bidder. **Credit cards are not accepted as payment.**

7. If the purchase price has not been paid within the time limit specified above, nor lots taken up within 7 days from the date of sale, the lots will be resold by whatever means deemed appropriate by the Galleries, and any loss incurred from resale will be charged to the defaulting buyer. Any account more than 30 days in arrears will be subject to a late payment charge of 1½% per month as long as the account remains in arrears. Any expenses incurred in securing payment from delinquent accounts will be charged to the defaulter. A fee of \$250.00 per check will be charged for each check returned for insufficient funds.
8. All lots are sold as genuine. **Any lot accompanied by a certificate issued by The Philatelic Foundation within 5 years of the sale date or by Professional Stamp Experts since January 2004 is sold "as is" and in accordance with the description on the certificate. Such lots may not be returned for any reason, including but not limited to a contrary certificate of opinion.** Buyers who wish to obtain a certificate for any item that does not have a P.F. or P.S.E. certificate (dated as above) may do so, provided that the following conditions are met: (1) the purchase price must be paid in full, (2) the item must be submitted to an acceptable expertizing committee with a properly executed application form within 21 days of the sale, (3) a copy of the application form must be given to the Galleries, (4) in the event that an adverse opinion is received, the Galleries retain the right to resubmit the item on the buyer's behalf for reconsideration, without time limit or other restrictions, (5) unless written notification to the contrary is received, items submitted for certification will be considered cleared 90 days from the date of sale, and (6) in the event any item is determined to be "not as described", the buyer will be refunded the purchase price and the certification fee up to \$600.00 unless otherwise agreed.
9. Until paid for in full, all lots remain the property of the Galleries on behalf of the seller.
10. Agents executing bids on behalf of clients will be held responsible for all purchases made on behalf of clients unless otherwise arranged prior to the sale.
11. The buyer assumes all risk for delivery of purchased lots and agrees to pay for prescribed shipping costs. Buyers outside the U.S. are responsible for all customs duties.
12. **The bidder consents that any action or proceeding against it may be commenced and maintained in any court within the State of New York or in the United States District Court for the Southern District of New York, that the courts of the State of New York and United States District Court for the Southern District of New York shall have jurisdiction with respect to the subject matter hereof and the person of the bidder. The bidder agrees not to assert any defense to any action or proceeding initiated by Galleries based upon improper venue or inconvenient forum. The bidder agrees that any action brought by the bidder shall be commenced and maintained only in a Federal Court in the United States District Court for the Southern District of New York or the State Court in the county in which Galleries has its principal place of business in New York. These Terms and Conditions shall be governed by and construed in accordance with the substantive laws of the State of New York.**

Grades, Abbreviations and Values Used in Descriptions

Grades and Centering

Our descriptions contain detailed information and observations about each item's condition. We have also assigned grades to stamps and covers, which reflect our subjective assessment. For stamps, the margin width, centering and gum are described and graded according to generally-accepted standards (an approximate correlation to numeric grades is provided at right). Although we believe our grades are accurate, they are not always exactly aligned with third-party grading terms or standards for all issues. **A lot may not be returned because a certification service grades a stamp lower than the grade stated in the description. Information from the P.S.E. Stamp Market Quarterly and P.S.E. Population ReportSM is the most current available, but lots may not be returned due to errors or changes in statistics or data.**

Extremely Fine Gem (90-100): The term "Gem" describes condition that is the finest possible for the issue. This term is equivalent to "Superb" used by grading services.







Extremely Fine (80-90): Exceptionally large/wide margins or near perfect centering.

Very Fine (70-85): Normal-size margins for the issue and well-centered with the design a bit closer to one side. "Very Fine and choice" applies to stamps that have desirable traits such as rich color, sharp impression, freshness or clarity of cancel.

Fine (60-70): Smaller than usual margins or noticeably off center. Pre-1890 issues may have the design touched in places.

Very Good (below 60): Attractive appearance, but margins or perforations cut into the design.

Covers

Minor nicks, short edge tears, flap tears and slight reduction at one side are normal conditions for 19th century envelopes. Folded letters should be expected to have at least one file fold. Light cleaning of covers and small mends along the edges are accepted forms of conservation. Unusual covers may have a common stamp with a slight crease or tiny tear. **These flaws exist in virtually all 19th century covers and are not always described. They are not grounds for return.**

Catalogue Values and Estimates

Unless otherwise noted, the currently available *Scott Catalogue* values are quoted in dollars with a decimal point. Other catalogues are often used for foreign countries or specialized areas and are referred to by their common name: *Stanley Gibbons* (SG), *Dietz*, *American Air Mail Catalogue* (AAMC), *Michel*, *Zumstein*, *Facit*, etc. Estimates are indicated with an "E." and reflect our conservative valuation in dollars. Reserves will never exceed the low end of the estimate range; they will sometimes exceed Scott Catalogue value for stamps in Extremely Fine condition.

Because of certain pricing inconsistencies in the *Scott Catalogue*—for example, blocks that have no gum, the absence of premiums for Mint N.H. items, etc.—we cannot guarantee the accuracy of values quoted for multiples, specialized items and collection lots. We generally try to be conservative, but buyers may not return a lot because of a discrepancy in catalogue value due to Scott pricing inconsistencies.

Therefore, the 1c 1851 Type D is the rarest of all United States stamps issued regularly prior to the 1868 Gills.</p> <p>Because of the significance attached to the outer portions of the 1c 1851 design, rare types that have been carefully cut apart, so as not to impair on any part of the design, are extremely desirable. The narrow spacing between stamps in the sheet and the more indifference to the cutting arrangement during separation are factors that contributed to the great rarity of four-margin examples. The example offered here comes from the "Warner strip" of Positions 78-1E, which was cut apart with a view towards preserving the margins of this stamp. Examples of Position 78-1E (Scott 3) with large right and bottom margins, where there was very little space between it and the adjoining stamps, are true rarities. The Siegel Encyclopedia and Rarities Census

This feature of our website contains a wealth of information gleaned from decades of philatelic research by the dedicated philatelists at Siegel. The up-to-date census data for 19th and 20th century U.S. rarities are a valuable resource for buyers, sellers and researchers. Every recorded example of more than 30 different rare stamps is described and, in most cases, photographed.

Our updated census of Scott 396 records thirteen used stamps. None is recorded unused. Of the five non-precanceled stamps, two have major faults and one has poor centering. There are the only three well-centered non-precanceled examples in existence.

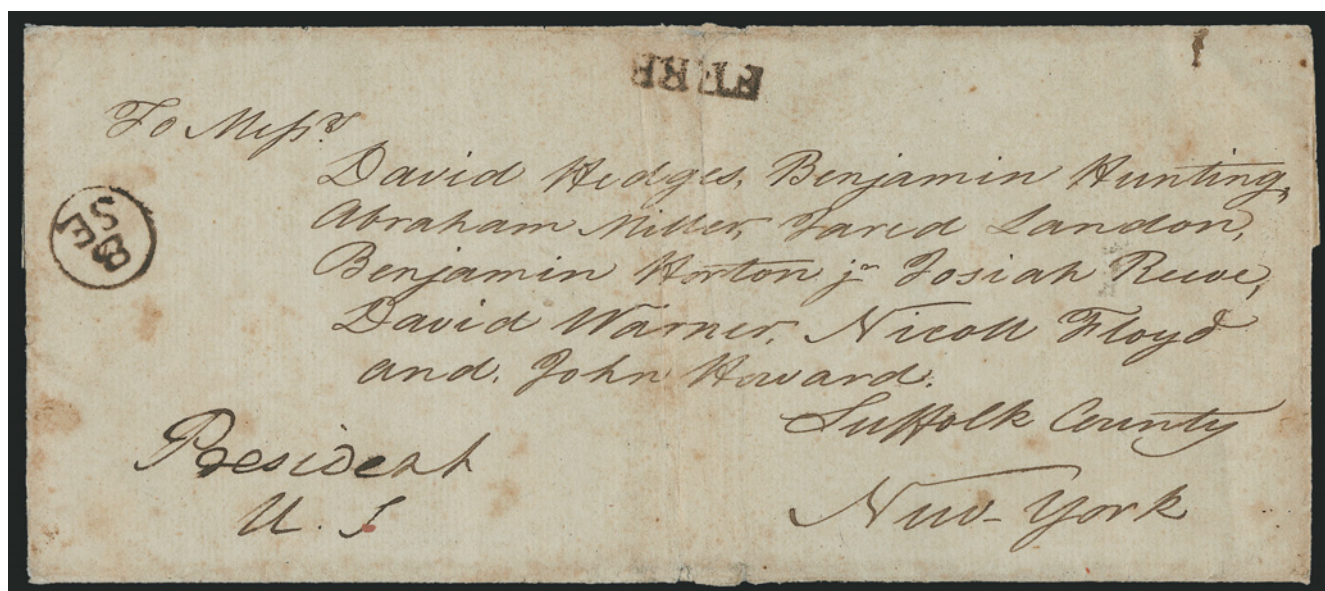

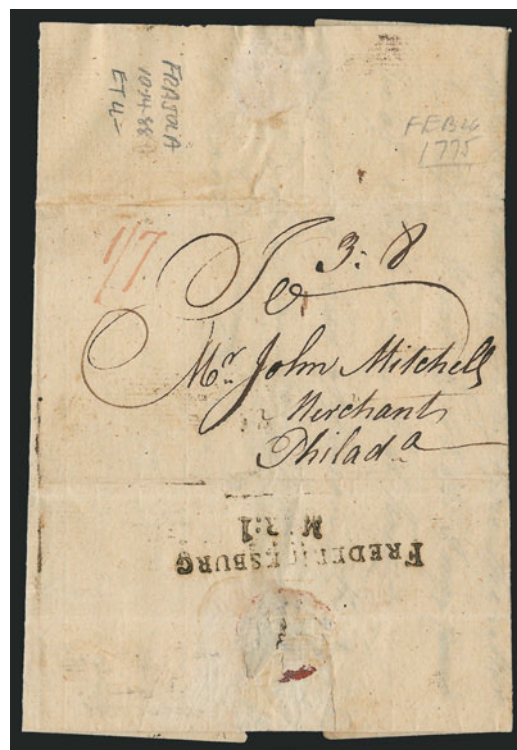

- 3009 ☒ **(Bacon's Rebellion, Virginia 1676).** Folded letter datelined "Whitehall 14 Novr. 1676" from John Maitland to his brother, Charles, Third Earl of Lauderdale, in Scotland, refers to Bacon's Rebellion — "we have got good news from Virginia of a very hopefull & speedie end of that traitor Bacon's rebellion" — no postal markings, carried outside the mails in Scotland, Very Fine, Nathaniel Bacon was a plantation owner in Virginia who led a rebellion against the aristocratic colonial government, which grew out of the discontent of back country farmers and conflict with Indian tribes; this is a very early reference to events in Colonial Virginia E. 500-750
- 3010 ☒ **(Fredericksburg Va., 1755) "from Rappannack River some miles below Fredericksburgh in Virginia".** Folded letter with origin stated in content and datelined "Virginia, Feby 10th 1755" from David Ogilvy to James Smyth in Edinburgh "care of the London Post Office", carried by private ship, ms. "In 10" pence British rate, "2/MA" (Mar. 2) Bishop's mark, letter refers to anticipated action in "an intense war", giving details of impending French and Indian War, minor toning inside letter and small opening nicks along top fold, still Very Fine, a scarce early Virginia Colonial letter regarding the French and Indian War, ex Faulstich..... - 3011 ☒ **(Colchester Va., 1774) "Way" and "Colchester 1.8".** Ms. postmarks and 1dwt8gr rate on folded letter datelined "Annapolis 30th June 1774" to William Carr in Dumfries Va., minor toning and erosion at bottom, Very Fine, handed to a mail carrier en route from Alexandria to Colchester, where put into the mails, and rated 1dwt8gr (4p) for 1765 rate under 60 miles..... VERY FINE. ATTRACTIVE AND CLEARLY STRUCK EXAMPLE OF THE RARE "FREDERICKSBURG" BRITISH COLONIAL STRAIGHTLINE DURING THE TRANSITIONAL PERIOD IN 1775.

VERY FINE. A BEAUTIFUL STRIKE OF THE RARE "FREDERICKSBURG" BRITISH COLONIAL STRAIGHTLINE DURING THE TRANSITIONAL PERIOD IN 1775.

Although some postal historians have presented this cover as an early Goddard Constitutional Post usage, it is almost certainly a late British Colonial marking and rate. In early 1775 the British General Post Office directed its American post offices to rate letters in pence (thus the "N10"), and the style of this straightline marking was introduced before the creation of opposition posts in the Colonies in rebellion, so the claim that markings of this type were Goddard handstamps is unsupportable. Nonetheless, this is a very rare and desirable cover from the fascinating transitional period of 1774-1775. ASCC value \$750.00 E. 1,000-1,500

Kennedy, a British soldier, writing to his father in Glasgow, Scotland, letter mentions Lord Dunmore and predicts "matters will not be settled without hard knocks", partly readable strikes of "SHIP" handstamp and "GREN/OCK" backstamp, soiled and minor edge faults, Fine, mail from British soldiers in Virginia during the Revolutionary War is scarce..... - 3015 ` **(Virginia, 1776) "Virginia, 6 July 1776"**. Receipt docketing on folded letter written two days after Declaration of Independence from William Shedden to John Patrick in Scotland, sender's routing "p. the Neptune, Capt. Wilson, Q.D.C.", "SHIP" straightline handstamp, interesting content refers to summoning of delegates for Aug. 1, 1776, local resolutions and British tax ("They generally resolve that Great Britain has no right to tax them. That they ought to stop all connexion with Great Britain."), tears, soiling and some minor faults, very historical and desirable, ex Meroni E. 500-750
- 3016 ☒ **(Fredericksburg Va., 1777) "Fredbg. 3.8"**. Manuscript postmark and 3dwt8gr rate on July 1, 1777 folded letter to "The Managers of the United States Lottery Office" in Philadelphia, slightly toned and split along folds, still Very Fine, this is the listing example in ASCC (value \$300.00). - 3017 ☒ **(Alexandria Va., 1779) "10" (dwt) Resolution of Apr. 16, 1779 Inflation Rate.** Ms. "10" rate without any other postal markings on folded letter datelined "Alexandria Novembr. 24th 1779" to Samuel Coates in Philadelphia, light soiling and wear along fold, Very Fine, the 1775 rate was 3dwt8gr, due to inflation the Resolution of 10/17/1777 increased rates by 50%, the Resolution of 4/16/1779 doubled the 1777 rates (the conversion raises 3dwt8gr to 10dwt), examples of the April 1779 inflation rates are rare E. 400-500

- 3019 ☒ **(Petersburg Va., 1785) "Petersburg Way 4"**. Manuscript way postmark and 4dwt rate on Apr. 6, 1785 folded letter from Petersburg to Baltimore, minor wear and age spots, otherwise Very Fine E. 300-400
- 3020 ☒ **(Virginia, 1785) "Robert Carter Esqr., Nominy Hall"**. Address on privately-carried folded cover with receipt docketing "Phillip Lee 27 Jany. 1785", the addressee was the grandson of Robert "King" Carter, the most prominent proprietor of Colonial Virginia, Very Fine..... E. 200-300

Folded letter datelined "Norwich 3d April 1787" to Alexandria Va., sender's routing "By New York Packet, postpaid to New York", red "SO NORWICH" straightline handstamp, brownish "POST/PAID" in circle handstamp, matching "4/AP" (Apr. 4) Bishop's mark on back, red "P 1N5" prepaid 1s packet rate and 5p internal British postage, "3.8" rate (3dwt8gr) fro New York to Virginia, wear and small tears along folds and file fold, still Fine, ex Faulstich E. 300-400
- 3022 ☒ **(Petersburg Va., 1789) Private Ship Letter to Scotland**. Folded letter datelined "Petersburg in Virginia, 4th Octr. 1789" to Dingwall, Scotland, sender's routing "Ship Isabella, Capt. Currie", brownish "SHIP" handstamp, matching "GREENOCK" straightline backstamp, red Bishop's mark struck off cover, ms. rates, Very Fine E. 300-400
- 3023 ☒ **(Rappahannock Forge Va., 1791-92) Covers to Fredericktown Md.** Two folded letters datelined at Rappahannock Forge Va. from Abner Vernon to Col. Baker Johnson in Fredericktown Md., each with sender's instructions "Colo. Deakins of George Town is Humbly requested to forward this", each with "Paid" handstamp, first dated Nov. 29, 1791, with "1.8" rate (1dwt 8gr), second dated Aug. 23, 1792, with "15" rate, both have minor edge tear at top, still Very Fine, the "Paid" was probably applied at Fredericksburg Va., the two nicely display 1788 rate in pennyweight and 1792 rate in U.S. cents E. 400-500

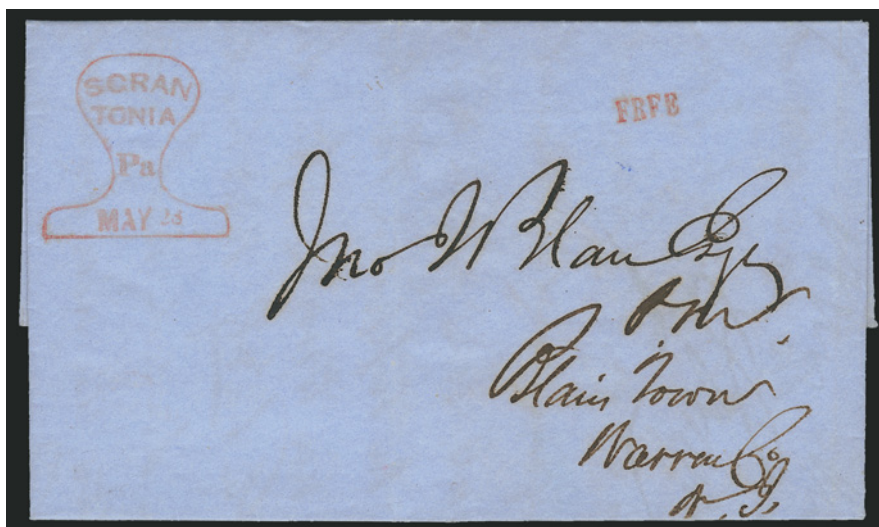

- 3031 ☒ **The Tobias Collection of Colonial and 18th Century Virginia Covers.** Balance of “working” collection sorted in box, comprising approximately 78 folded letters and covers, most dated 1780’s and 90’s (a few earlier, none later), wide range of town markings and usages, includes many scarce straightlines, varied rates, some ship mail (incl. privately-carried without postal markings), condition is far above average, minor faults to be expected but most are Fine-Very Fine, an outstanding opportunity to acquire the nucleus of a Virginia stampless cover collection, many of these covers are worth \$200-300 each, careful examination is essential and an aggressive bid is recommended*Not illustrated* E. 5,000-7,500

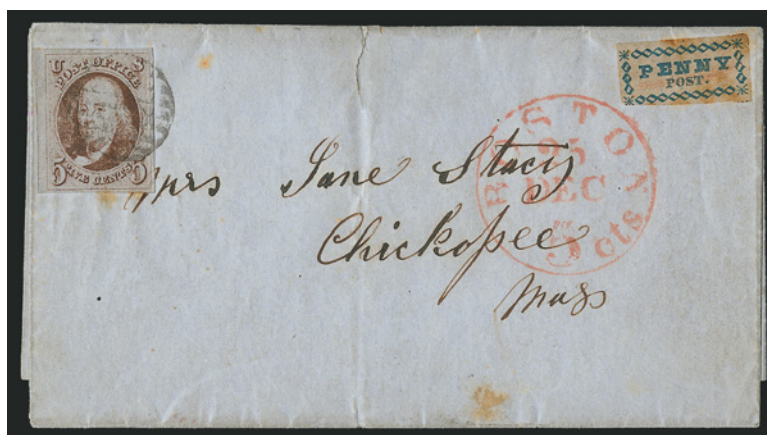

Lambertville negative circle (stained cover), Augusta "Horn of Plenty", usages begin to diversify around 1820's incl. "Mail Route", "Forwarded", 1836 Express Mail, Hale & Co., "Steam", Martin Van Buren free frank, ship letters, "Rail Road Car" straightline (a gorgeous strike and cover), July 1, 1845 first day followed by nice range of 1845-1863 usages incl. A NEW DISCOVERY IN THE FIELD OF CARRIERS AND LOCALS. THE HONOUR'S FIRST ISSUE WAS PREVIOUSLY KNOWN ONLY ON YELLOW AND BROWN ROSE PAPER. THIS STAMP ON BLUISH GRAY PAPER IS UNLISTED AND SCOTT AND PREVIOUSLY UNRECORDED.

This is the tenth recorded example of Honour's first-issue stamp. It recently came to light in an estate collection. Its emergence is all the more remarkable, because the stamp is printed on Bluish Gray paper, not the Yellow or Brown Rose papers identified in Scott as 4LB2 and 4LB1, respectively (we refer to them in reverse Scott order, because that is the correct chronological order).

John H. Honour, Superintendent of the Charleston Penny Post, advertised the commencement of carrier service in the *Charleston Mercury* on May 9, 1849. The earliest recorded Honour's cover is postmarked May 24, 1849, establishing the oval stamp on Yellow paper (Scott 4LB2, four recorded) as the likely first issue of the Charleston carrier stamps. The same design on Brown Rose paper (4LB1, five recorded) is known with July and August 1849 dates. The wording and configuration are identical to the contemporary Boyd's Eagle & Globe stamps (without the Eagle vignette). The Bluish Gray stamp paper on the newly-uncovered August 9, 1849, folded letter falls into the proper period of use for the oval stamp. The paper is comparable to the Bluish Gray paper used for the subsequent typeset issues.

The use of the Charleston S.C. carrier stamps on inbound mail originating in other cities (Aiken S.C., in particular) has been well-known to specialists for years. In 1875 a South Carolina philatelist named William H. Faber interviewed two of the men who had served as carriers in Charleston and learned that stamps were carried or sent to other places and used to prepay the carrier fees on mail addressed to Charleston (the Faber interviews were reported by John N. Luff in the *American Journal of Philately*, March 1898, and by Elliott Perry in *The Philatelist*, June 1974). This August 9, 1849, letter is the earliest recorded inbound cover with one of the Charleston carrier stamps. However, in our opinion, the Bluish Gray stamp on this cover was probably applied after the letter reached Charleston's carrier department. Based on patterns of stamp use in other carrier departments—for example, Philadelphia—we are convinced that certain carrier department stamps were sometimes applied by the carriers as receipts and as a means of recording how many letters they delivered and were paid for, rather than by the sender to prepay the carrier fee. As the photo shows, a piece of the stamp has been torn off, and the paper is skimmed in a triangular shape pointing toward the center, in the direction the paper was peeled. This damage might have been the result of a stamp collector trying to remove the stamp, but another possibility is that the carrier peeled off the "2 Cents" portion of the design. This might have been his way of "cancelling" the stamp once the 2c carrier fee and 5c postage was paid. Those who are skeptical of this theory should observe that the street address—"Canonsboro, end of Bee St."—is in handwriting that differs from the address and Graniteville postmark. A possible scenario is that the letter arrived at the Charleston post office and was given to the carrier department for delivery, based on standing instructions left by the addressee. The street address was added to the letter, and the carrier was instructed to collect 7c (5c postage plus 2c carrier fee). The carrier affixed the stamp as a receipt for money received, and he peeled off the bottom of the stamp (with denomination), which was otherwise left uncanceled. By using a stamp from his supply, the carrier could accurately report how much he received and was due for his services (the postage would be paid to the post office). Obviously, this theory is purely speculative, and the damage to the stamp might be pure philatelic vandalism. However, if a stamp collector intended to remove the stamp, why not finish the job? We believe the damage occurred in August 1849 at the hand of the Charleston carrier..... E. 3,000-4,000

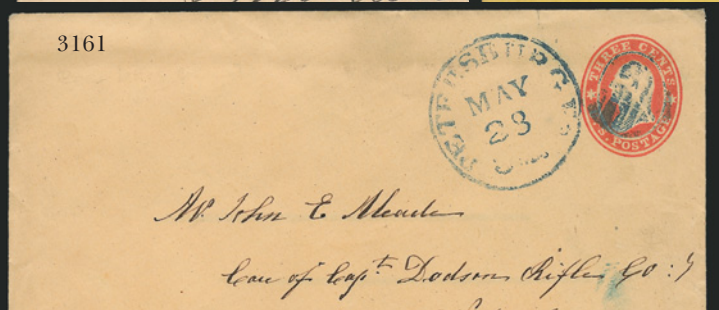

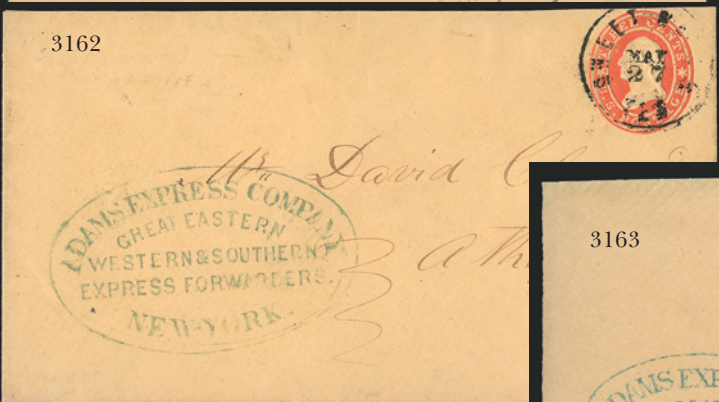

Only a few covers are recorded with this combination of Adams office markings, which were applied in transit entirely outside the U.S. and Confederate postal systems. Adams also had the option of placing letters into the Nashville post office for delivery by regular Confederate mails.

The Adams Knoxville oval is extremely rare, and collectors should be aware that a number of clever fakes were handled by John A. Fox, some of which have never been properly identified (these fakes bear the David Cleage address, a known correspondence). Perhaps the rarity of the Knoxville oval is appreciated less because of the circulating fakes.

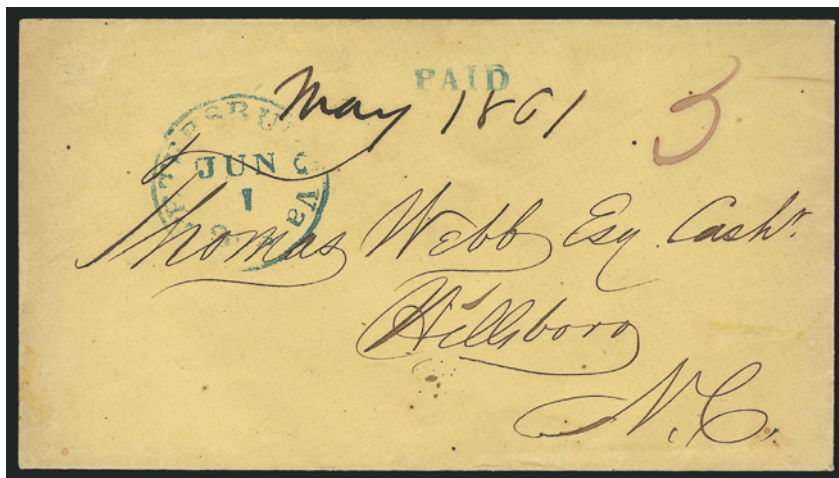

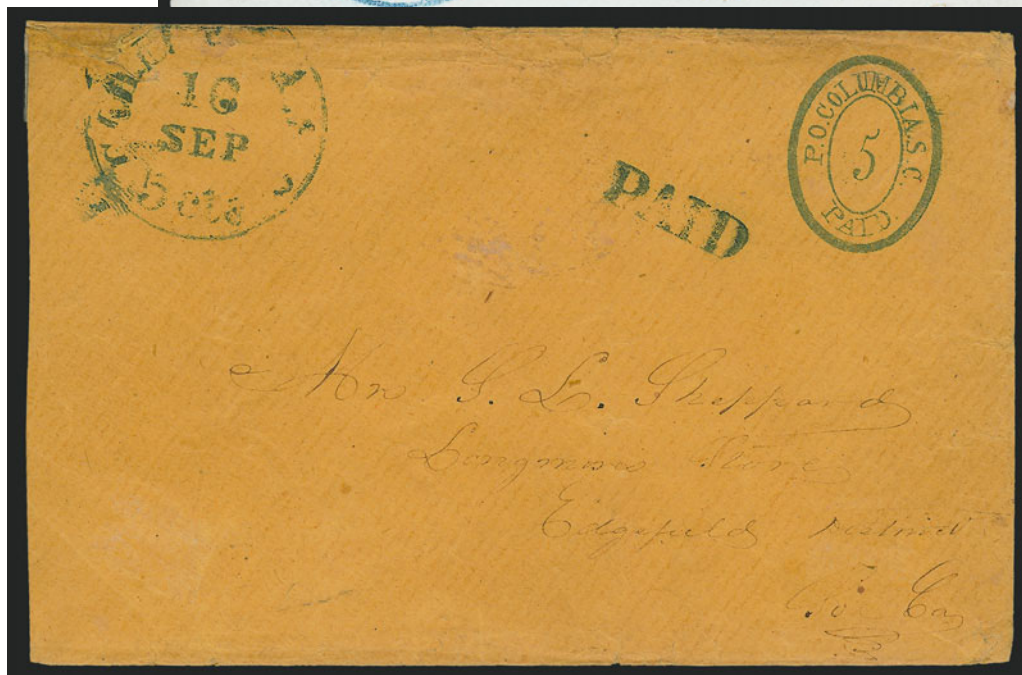

Our records of the rare Danville provisional stamp include eight examples, as follows. **Rectangular-cut margins:** 1) on piece dated Oct. 3, ex Ferrary, Caspary; 2) **laid paper**, off-cover with bottom right corner clipped, the stamp offered here, ex Hind; 3) dated Oct. 4, affixed to a cover, ex Hessel and Kilbourne; 4) tied on cover, Oct. 9, ex Caspary, Lilly; **Octagonal margins or cut to shape:** 5) off cover, dated Oct. 3, ex Caspary; 6) tied on cover, Oct. 29, ex Emerson; 7) tied on cover, Oct. 30, ex Kimmel; and 8) cut to small oval shape, dated Oct. 11, ex Deats (P.F. photo files).

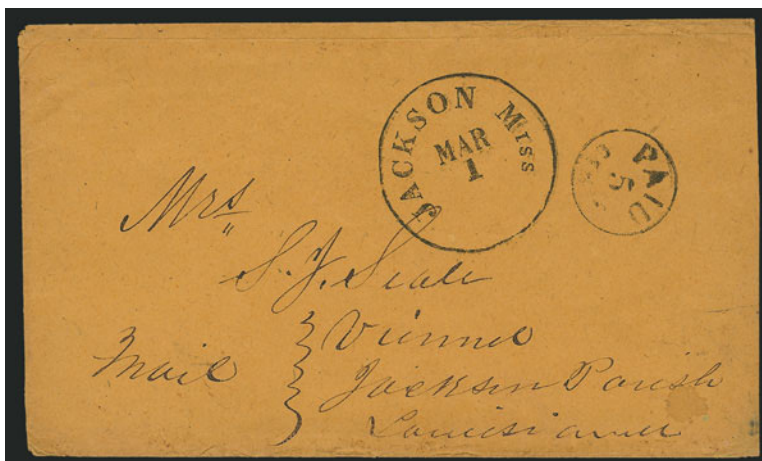
Only four rectangular-cut examples of the Danville provisional stamp are recorded. Until now, we had to rely on earlier descriptions of this stamp's paper. Now that we have had the opportunity to examine it, we can state unequivocally that the paper has strong vertical laid lines. Therefore, it deserves a major Scott number (21X2) and recognition as **the only recorded Danville adhesive on laid paper**. This is truly one of the rarest of all Confederate provisionals, and should not be confused with its more numerous counterpart from Pittsylvania Court House, which is known on wove and laid paper.

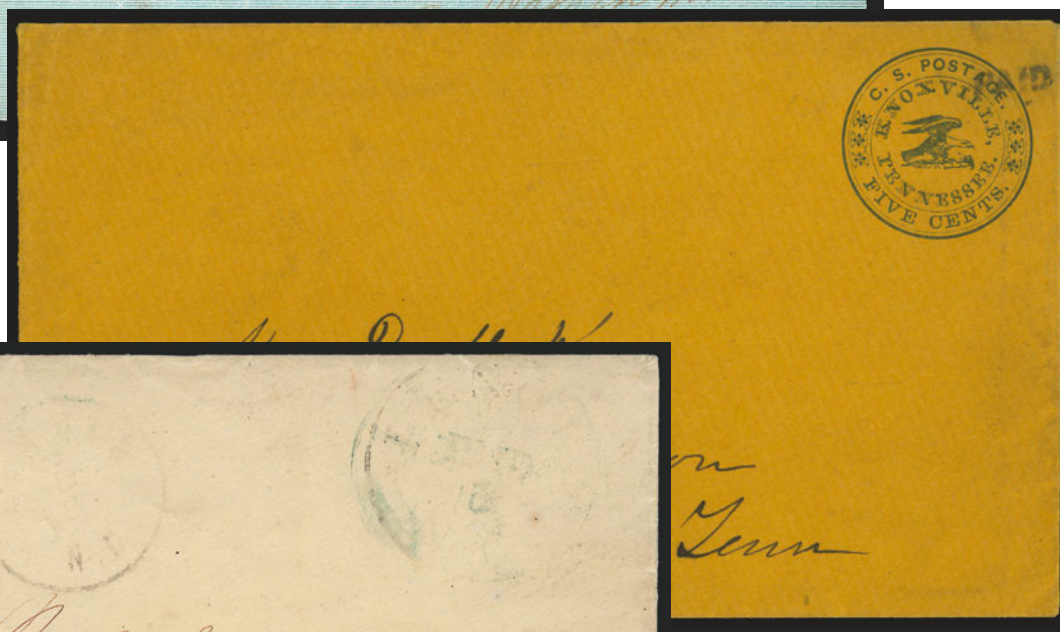

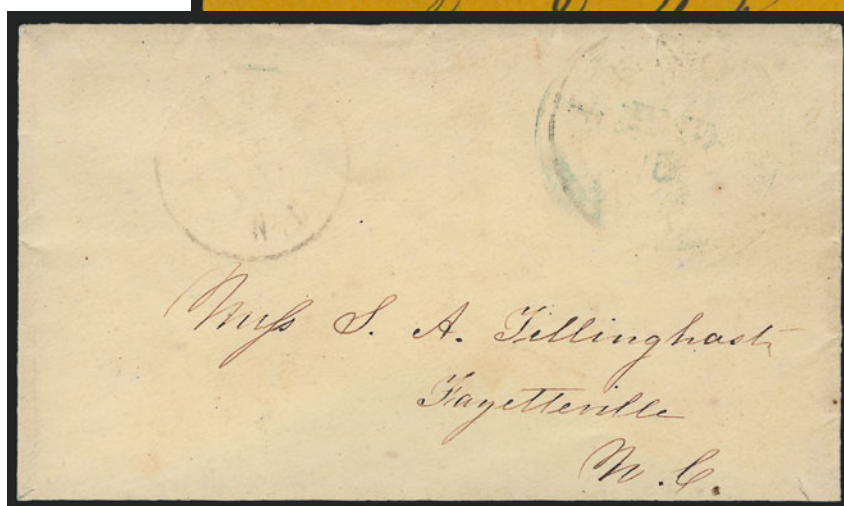

VERY FINE APPEARANCE. THIS STAMP IS ONE OF ELEVEN RECORDED EXAMPLES OF THE LIVINGSTON POSTMASTER'S PROVISIONAL, ON OR OFF COVER. A RARE OPPORTUNITY TO OWN ONE OF THE MOST FAMOUS AND DESIRABLE OF ALL CONFEDERATE POSTMASTERS' PROVISIONALS.

Livingston is the county seat of Sumter County, Alabama, lying on the Selma and Meriden Railroad line about 130 miles north of Mobile, near the state's western border. Official records name Stephen W. Murley as the Livingston postmaster in 1861, while other sources attribute the provisional stamp to another postmaster, Robert F. Houston. The Livingston provisional is known used in November-December 1861 and again in March 1862.

Our records contain a total of 11 stamps, including the famous and unique pair on cover (Nov. 12, 1861), 6 singles on separate covers (1861—Nov. 15, Nov. 15, Nov. 25, Dec. 10; 1862—Mar. 17 and Mar. 21), and 3 off-cover stamps. One of the single frankings, a corner-margin stamp (Nov. 25 date, ex Caspary, Antrim and Cole), was severely damaged through negligent restoration.

Only two Confederate post offices, Livingston and Mobile, issued stamps with a pictorial design. It is almost certain that the same printer was responsible for both, whose imprint "W. R. Robertson Mobile" appears on the Mobile lithographic stones. The composition of the Livingston plate is not known, but a pane of 20 subjects may be reasonably conjectured.
