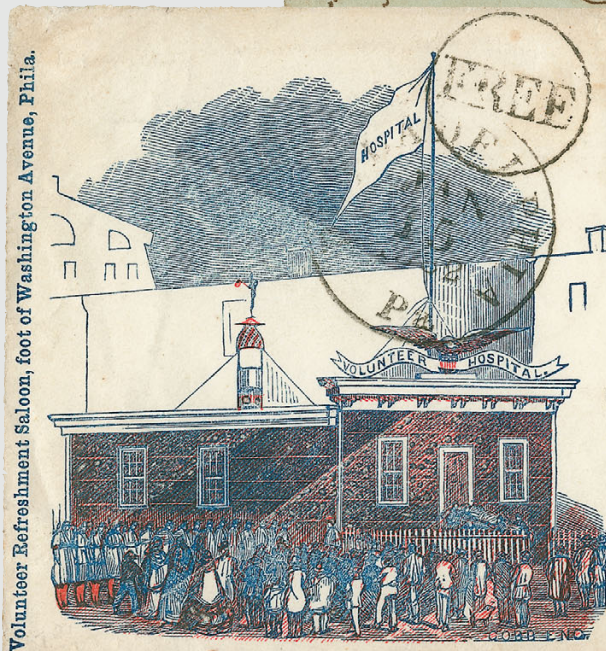
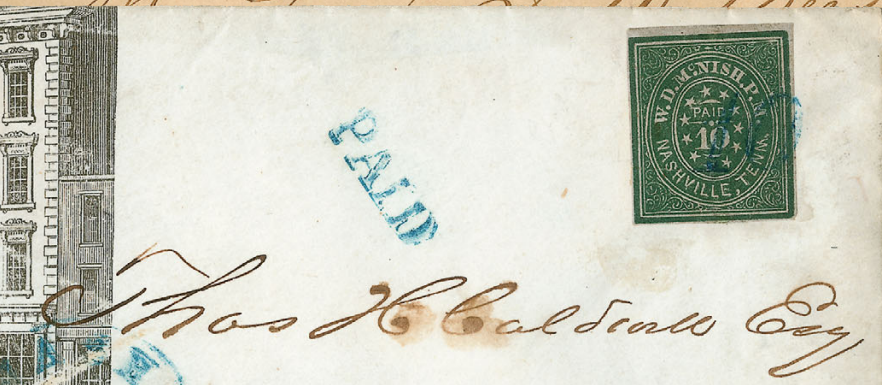
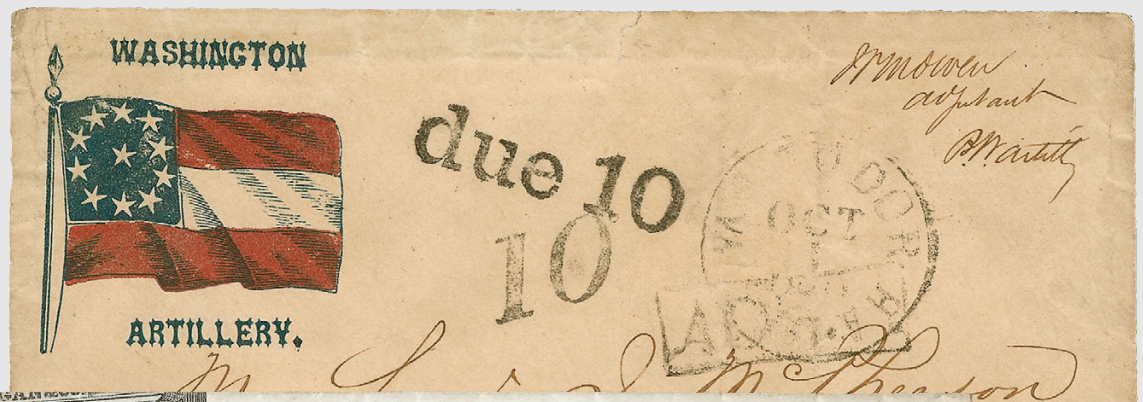

## Information for Bidders

### Bidding

The following means are available for placing bids:

- 1) Attending the Live Auction in Person:** All bidders must register for a paddle, and new bidders must provide references at least three business days in advance of the sale.
- 2) Live Internet Bidding:** Instructions for participating as a Live Internet Bidder are provided on the page opposite.
- 3) Phone Bidding:** Bidders can be connected to the sale by phone and bid through a member of staff. Requests for phone bidding are subject to approval (please contact our office at least 24 hours before the sale). A signed Bid Form is required.
- 4) Absentee Bids.** All bids received in advance of the sale, either by mail, fax, phone, e-mail or internet, are Absentee Bids, which instruct the auctioneer to bid up to a specific amount on one or more lots in the sale. Absentee Bids sent by phone, fax or e-mail should arrive at least one hour prior to the start of the sale session. Bids entered through Live Internet Bidding will be visible to the auctioneer during the sale. Written bids should be entered legibly on the Bid Form in the sale catalogue. E-mail and internet bids should be carefully typed and double-checked. All new bidders must provide references. We recommend calling or e-mailing to confirm that Absentee Bids sent by mail, fax or e-mail have been received and entered.

### Pre-Sale Viewing

Subject to availability, certain lots (except group lots) can be sent to known clients for examination. Requests must be made no later than 7 days prior to the sale. Lots must be returned on the day received. Postage/insurance costs will be invoiced.

In addition to regular viewing, clients may view lots by appointment. Our staff will be pleased to answer questions or provide additional information about lots.

### Expert Certification

Individual items offered without a PF or PSE certificate dated within the past five years may be purchased subject to independent certification of genuineness and our description. **Please refer to the Conditions of Sale and Grading Terms for policies governing certification.**

### Shipping and Delivery

Procedures and charges for shipping lots are printed on the back of the Bid Form. **Bidders are responsible for all prescribed shipping charges and any applicable sales tax or customs duties.**

### Price Realized

Prices realized are sent with each invoice. Bidders with e-mail will receive a Bid Results report after the sale. Session results are posted immediately to **siegelauctions.com**

### Registering with STAMP AUCTION NETWORK & SIEGEL AUCTION GALLERIES

Live Internet Bidding is managed by Stamp Auction Network (SAN).  
To bid, you must be registered and approved by *both* SAN and Siegel.  
To decide what you need to do, choose the description below that best fits you.



**I've already registered with SAN and have been approved by Siegel for internet bidding.**

**I'm a Siegel client, but I'm not registered with SAN.**

Go to [stampauctionnetwork.com/siegel](http://stampauctionnetwork.com/siegel) and click on "Register" at the top. Check the box for Robert A. Siegel Auction Galleries (under "R") and submit the form, indicating you are a Siegel client. Once registered at SAN, you're ready for internet bidding.

**I've bid through SAN before, but this is the first time I've bid in a Siegel sale.**

Then you just need to be approved by Siegel. Go to [stampauctionnetwork.com/siegel](http://stampauctionnetwork.com/siegel) and click on "Update Registration" at the top. Your SAN account information will be sent to us for approval (you might be asked for other trade references). Once approved by Siegel for bidding, you're ready for internet bidding.

**I've never bid with Siegel, nor registered with SAN.**

Go to [stampauctionnetwork.com/siegel](http://stampauctionnetwork.com/siegel) and click on "Register" at the top. Check the box for Robert A. Siegel Auction Galleries (under "R") and submit the form **with your trade references** (please, no family members or credit card companies as references). Once registered at SAN and approved by Siegel for bidding, you're ready for internet bidding.

Live Internet Bidding works by allowing registered bidders to observe and place bids.

Live Internet Bidding will work with any browser on both PC and Mac operating systems.

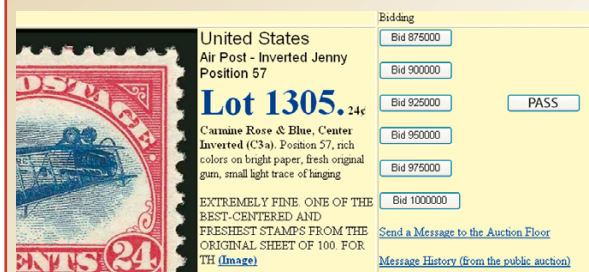
Before bidding by internet for the first time, we recommend finding a sale in progress and listening to the public broadcast or logging in as a registered bidder. This will help you develop a feel for the sale tempo and bidding interface.

You can also log on at [siegelauctions.com](http://siegelauctions.com)

When you're logged on as a Live Internet Bidder, the bidding interface shows a photo and description of the lot, the current bid (and your bidding status), options for placing competitive bids and buttons with bid increments.

- After you click on a bid amount, the auctioneer is immediately notified of your bid.
- Retracting a bid is usually not acceptable, so please bid carefully.
- If you bid and then decide to stop, the "Pass" button will tell the auctioneer you are no longer bidding.
- You can send messages to the auctioneer (for example, a request for extension).
- You can track prior realizations from the bidding screen.

## Conditions of Sale (please read carefully before bidding)

**THE PROPERTY DESCRIBED IN THIS CATALOGUE WILL BE OFFERED AT PUBLIC AUCTION BY ROBERT A. SIEGEL AUCTION GALLERIES, INC. ("GALLERIES") ON BEHALF OF VARIOUS CONSIGNORS AND ITSELF OR AFFILIATED COMPANIES. BY BIDDING ON ANY LOT, WHETHER DIRECTLY OR BY OR THROUGH AN AGENT, IN PERSON, OR BY TELEPHONE, FACSIMILE OR ANY OTHER MEANS, THE BIDDER ACKNOWLEDGES AND AGREES TO ALL OF THE FOLLOWING CONDITIONS OF SALE.**

1. The highest bidder acknowledged by the auctioneer shall be the buyer. The term "final bid" means the last bid acknowledged by the auctioneer, which is normally the highest bid offered. **The purchase price payable by the buyer will be the sum of the final bid and a commission of 15% of the final bid ("buyer's premium"), together with any sales tax, use tax or customs duties due on the sale.**
2. The auctioneer has the right to reject any bid, to advance the bidding at his discretion and, in the event of a dispute, to determine the successful bidder, to continue the bidding or to reoffer and resell the lot in dispute. The Galleries' record of the final sale shall be conclusive.
3. All bids are per numbered lot in the catalogue unless otherwise announced by the auctioneer at the time of sale. The right is reserved to group two or more lots, to withdraw any lot or lots from the sale, or to act on behalf of the seller. The Galleries will execute bidding instructions on behalf of clients, but will not be responsible for the failure to execute such bids or for any errors in the execution of such bids.
4. **Lots with numbers followed by the symbol ° are offered subject to a confidential minimum bid ("reserve"), below which the lot will not be sold. The absence of the symbol ° means that the lot is offered without a reserve. If there is no reserve, the auctioneer has sole discretion to establish a minimum opening bid and may refuse an offer of less than half of the published estimate. Any lot that does not reach its reserve or opening bid requested by the auctioneer will be announced as "passed" and excluded from the prices realized lists after the sale. The Galleries may have a direct or indirect ownership interest in any or all lots in the sale resulting from an advance of monies or goods-in-trade or a guarantee of minimum net proceeds made by the Galleries to the seller.**
5. Subject to the exclusions listed in 5(A), the Galleries will accept the return of lots which have been misidentified or which have obvious faults that were present when the lot was in the Galleries' custody, but not so noted in the lot description. **All disputed lots must be received by the Galleries intact with the original packing material within 5 days of delivery to the buyer but no later than 30 days from the sale date.**  
**(5A) EXCLUSIONS: The following lots may not be returned for any reason, or may not be returned for the reasons stated: i) lots containing 10 or more items; ii) lots from buyers who registered for the pre-sale exhibition or received lots by postal viewing, thereby having had the opportunity to inspect them before the sale; iii) any lot described with "faults," "defects" or a specific fault may not be returned because of any secondary fault; iv) photographed lots may not be returned because of centering, margins, short/nibbed perforations or other factors shown in the illustrations; v) the color of the item does not match the color reproduction in the sale catalogue or website listing; vi) the description contains inaccurate information about the quantity known or reported; or vii) a certification service grades a stamp lower than the grade stated in the description.**
6. Successful bidders, unless they have established credit with the Galleries prior to the sale, must make payment in full before the lots will be delivered. Buyers not known to the Galleries must make payment in full within 3 days from the date of sale. **The Galleries retains the right to demand a cash deposit from anyone prior to bidder registration and/or to demand payment at the time the lot is knocked down to the highest bidder, for any reason whatsoever.** In the event that any buyer refuses or fails to make payment in cash for any lot at the time it is knocked down to him, the auctioneer reserves the right to reoffer the lot immediately for sale to the highest bidder. **Credit cards (Visa, Mastercard and Discover only) can be accepted as payment but will be subject to a 3% Convenience Fee, which will be added to the total of the entire invoice (including hammer price, buyer's premium, shipping and transit insurance charges and any applicable taxes).**
7. If the purchase price has not been paid within the time limit specified above, nor lots taken up within 7 days from the date of sale, the lots will be resold by whatever means deemed appropriate by the Galleries, and any loss incurred from resale will be charged to the defaulting buyer. **Any account more than 30 days in arrears will be subject to a late payment charge of 1½% per month as long as the account remains in arrears. Any expenses incurred in securing payment from delinquent accounts will be charged to the defaulter.** A fee of \$250.00 per check will be charged for each check returned for insufficient funds.
8. All lots are sold as genuine. **Any lot accompanied by a certificate issued by The Philatelic Foundation or by Professional Stamp Experts within 5 years of the sale date is sold "as is" and in accordance with the description on the certificate. Such lots may not be returned for any reason, including but not limited to a contrary certificate of opinion.** Buyers who wish to obtain a certificate for any item that does not have a P.F. or P.S.E. certificate (dated as above) may do so, provided that the following conditions are met: (1) the purchase price must be paid in full, (2) the item must be submitted to an acceptable expertizing committee with a properly executed application form within 21 days of the sale, (3) a copy of the application form must be given to the Galleries, (4) in the event that an adverse opinion is received, the Galleries retain the right to resubmit the item on the buyer's behalf for reconsideration, without time limit or other restrictions, (5) unless written notification to the contrary is received, items submitted for certification will be considered cleared 90 days from the date of sale, and (6) in the event any item is determined to be "not as described", the buyer will be refunded the purchase price and the certification fee up to \$800.00 unless otherwise agreed to in writing.
9. Until paid for in full, all lots remain the property of the Galleries on behalf of the seller.
10. Agents executing bids on behalf of clients will be held responsible for all purchases made on behalf of clients unless otherwise arranged prior to the sale.
11. The buyer assumes all risk for delivery of purchased lots and agrees to pay for prescribed shipping costs. **Buyers who receive lots in the U.S. are obligated to pay whatever sales tax or compensating use tax might be due, and buyers outside the U.S. are responsible for all customs duties.**
12. **The bidder consents that any action or proceeding against it may be commenced and maintained in any court within the State of New York or in the United States District Court for the Southern District of New York, that the courts of the State of New York and United States District Court for the Southern District of New York shall have jurisdiction with respect to the subject matter hereof and the person of the bidder. The bidder agrees not to assert any defense to any action or proceeding initiated by Galleries based upon improper venue or inconvenient forum. The bidder agrees that any action brought by the bidder shall be commenced and maintained only in a Federal Court in the United States District Court for the Southern District of New York or the State Court in the county in which Galleries has its principal place of business in New York. The bidder agrees not to use a public conflict resolution service and not to use any form of social media to publish comments or information about the Galleries and its employees which might harm the Galleries' reputation or business. These Conditions of Sale shall be governed by and construed in accordance with the substantive laws of the State of New York, and shall constitute an agreement that shall be binding on the parties, and their respective heirs, administrators, distributees, successors and assignees.**

## Grades, Abbreviations and Values Used in Descriptions

### Grades and Centering

Our descriptions contain detailed information and observations about each item's condition. We have also assigned grades to stamps and covers, which reflect our subjective assessment. For stamps, the margin width, centering and gum are described and graded according to generally-accepted standards (an approximate correlation to numeric grades is provided at right). Although we believe our grades are accurate, they are not always exactly aligned with third-party grading terms or standards for all issues. **A lot may not be returned because a certification service grades a stamp lower than the grade stated in the description. Information from the P.S.E. Stamp Market Quarterly and P.S.E. Population Report<sup>SM</sup> is the most current available, but lots may not be returned due to errors or changes in statistics or data.**

**Extremely Fine Gem (90-100):** The term "Gem" describes condition that is the finest possible for the issue. This term is equivalent to "Superb" used by grading services.







**Extremely Fine (80-90):** Exceptionally large/wide margins or near perfect centering.

**Very Fine (70-85):** Normal-size margins for the issue and well-centered with the design a bit closer to one side. "Very Fine and choice" applies to stamps that have desirable traits such as rich color, sharp impression, freshness or clarity of cancel.

**Fine (60-70):** Smaller than usual margins or noticeably off center. Pre-1890 issues may have the design touched in places.

**Very Good (below 60):** Attractive appearance, but margins or perforations cut into the design.

### Covers

Minor nicks, short edge tears, flap tears and slight reduction at one side are normal conditions for 19th century envelopes. Folded letters should be expected to have at least one file fold. Light cleaning of covers and small mends along the edges are accepted forms of conservation. Unusual covers may have a common stamp with a slight crease or tiny tear. **These flaws exist in virtually all 19th century covers and are not always described. They are not grounds for return.**

### Catalogue Values and Estimates

Unless otherwise noted, the currently available *Scott Catalogue* values are quoted in dollars with a decimal point. Other catalogues are often used for foreign countries or specialized areas and are referred to by their common name: *Stanley Gibbons* (SG), *Dietz*, *American Air Mail Catalogue* (AAMC), *Michel*, *Zumstein*, *Facit*, etc. Estimates are indicated with an "E." and reflect our conservative valuation in dollars. Reserves will never exceed the low end of the estimate range; they will sometimes exceed Scott Catalogue value for stamps in Extremely Fine condition.

Because of certain pricing inconsistencies in the *Scott Catalogue*—for example, blocks that have no gum, the absence of premiums for Mint N.H. items, etc.—we cannot guarantee the accuracy of values quoted for multiples, specialized items and collection lots. We generally try to be conservative, but buyers may not return a lot because of a discrepancy in catalogue value due to Scott pricing inconsistencies.

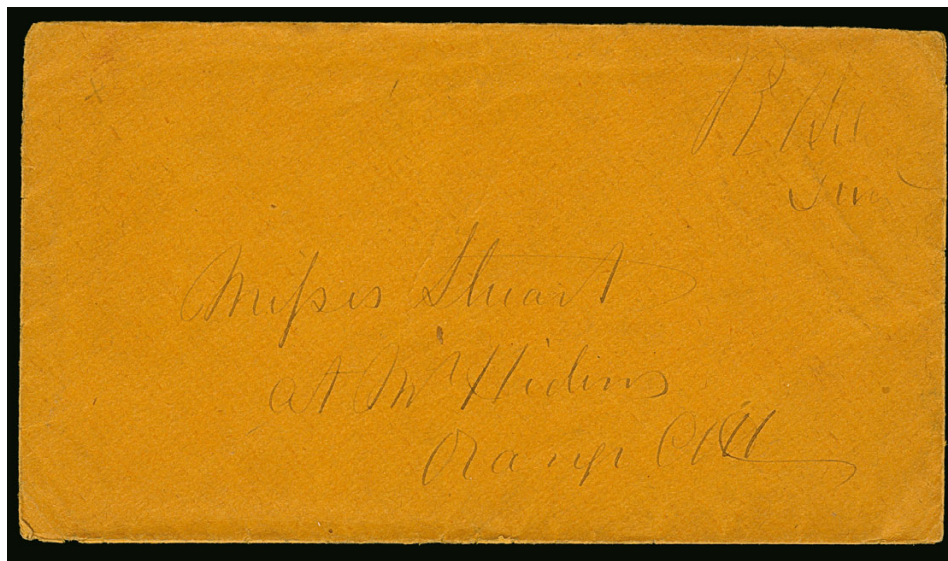

The letter reads: “My dear Cousin Margaret, I take advantage of a few quiet moments this holy ? to write to you, for the thought of you always brings me pleasure & adds to my Causes of gratitude to our merciful God for all the blessings bestowed upon me. I have recently returned from Richmond, where I thought much of you & wished for your presence that afforded so much pleasure to my former visit. I caught glimpses of Sweet Carrie but she was so surrounded by her little because that little could be got from her. But there was one tall one with her, a signal man, of that voracious family of Randolphs, whom I threatened with Castle Thunder. I did not see her look at Rob once. But you know he is to take her home on certain conditions. I hope your mother has given her Consent & that the Cakes are baking. I also saw happy Mrs. Ada. Her face was luminous with Content & she looked as if she thought there was but one person in the world. Mrs. Randolph was as handsome as ever & she was as kind & sweet as she is beautiful. Nothing more can be said for her. Mrs. R is much better & looks indeed quite well. But I was ? at the Condition in which I found your poor Cousin Mary. She is now a great sufferer, Cannot walk at all & can scarcely move. But Mildred has returned and I hope now she has all her daughter with her she will be more Comfortable. She is going to move to my old quarters, next to Mrs. Randolph’s. Go down and help dispense the Club. The members are all aghast. ## SANITARY FAIRS—VOLUNTEER REFRESHMENT SALOON

According to the Kantor book, the Union Volunteer Refreshment Saloon and Hospital was open from May 17, 1861, to August 28, 1865. "Troops passing thru Philadelphia to and from Washington could get refreshments, a hot meal and a place to rest on the way. The home-cooked meals were a welcome relief after the hardtack and worm-infested meat usually fried to a crisp in bacon grease. By the time it closed after four years of operation, over 600,000 meals had been served and over \$85,000 raised in contributions."

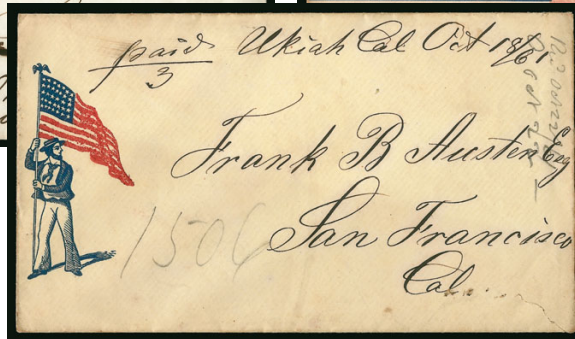

After the expiration dates, any old-style embossed envelope or adhesive stamp would be marked “Old Stamps Not Recognized” and postage due. Nesbitt and Star Die entires are known bearing the “Old Stamps Not Recognized” handstamp dated on August 17 and 19, 1861. The earliest recorded use of this marking on an adhesive is August 26, 1861, the first day the stamps were invalid for postage in Philadelphia.

Thanks to research by Richard L. Calhoun, the unusual Emory provisional stamp made from the selvage of United States 1c 1857 sheets can be properly attributed to Professor Edmund Longley, rather than his successor, Isaac C. Fowler (Richard L. Calhoun, "Emory, Virginia, Postmasters and Provisionals," *Confederate Philatelist*, October-December 2011, and *The Confederate Postmaster Provisionals of Virginia*).

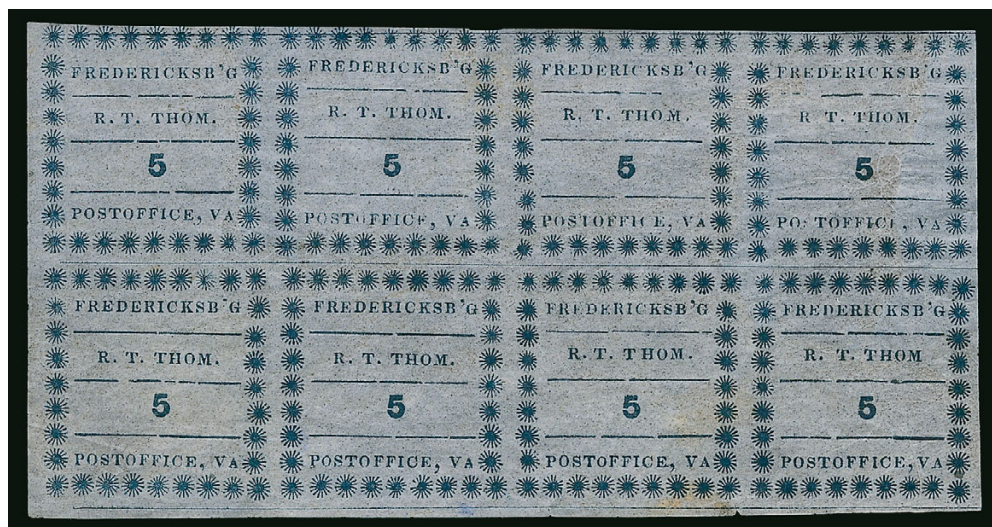
Longley, a professor at Emory & Henry College, served as U.S. postmaster of Emory (appointed January 12, 1847) and as C.S.A. postmaster from July 27 to August 30, 1861, when Fowler was appointed to replace Longley. The Emory provisional adhesives were issued during Longley's term.

Postmaster Longley created his provisional issue by stamping the office "Paid" and "5" rate markings on the blank selvage of United States 1c 1857 Issue sheets. This method is unique among Confederate provisionals and, in all of philately, there are only a few issues created from the sheet selvage of other stamps. The Philadelphia carrier stamps made from the selvage of imperforate 1c 1851 sheets are similar in concept to the Emory provisionals.

The Calhoun census and our own records are in accord with nine covers bearing the Emory provisional (we know of no off-cover stamps), ranging in dates from June 24, 1861, to February 11, 1862. There are three known stamp formats: Paid over 5; Paid under 5; and 5 with Paid at top and side (narrow selvage). Two of the nine recorded covers have manuscript town postmarks, and four have stamps left uncanceled. This is the only forwarded cover; forwarding postage should not have been charged since this was sent to a military address — a Captain in the 45th Regiment Virginia Volunteers.

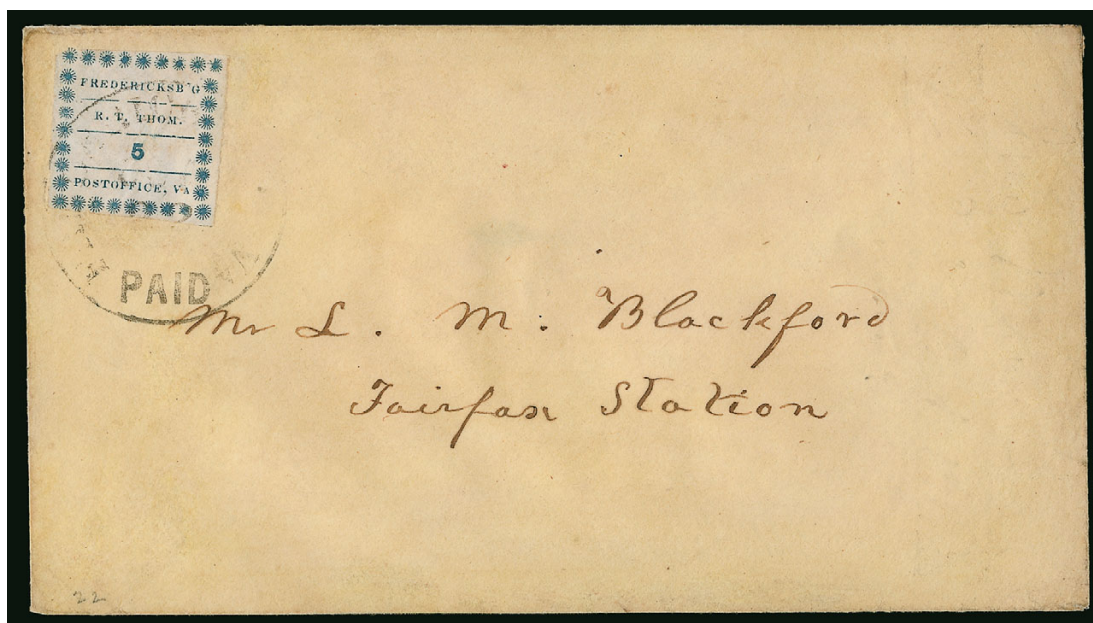

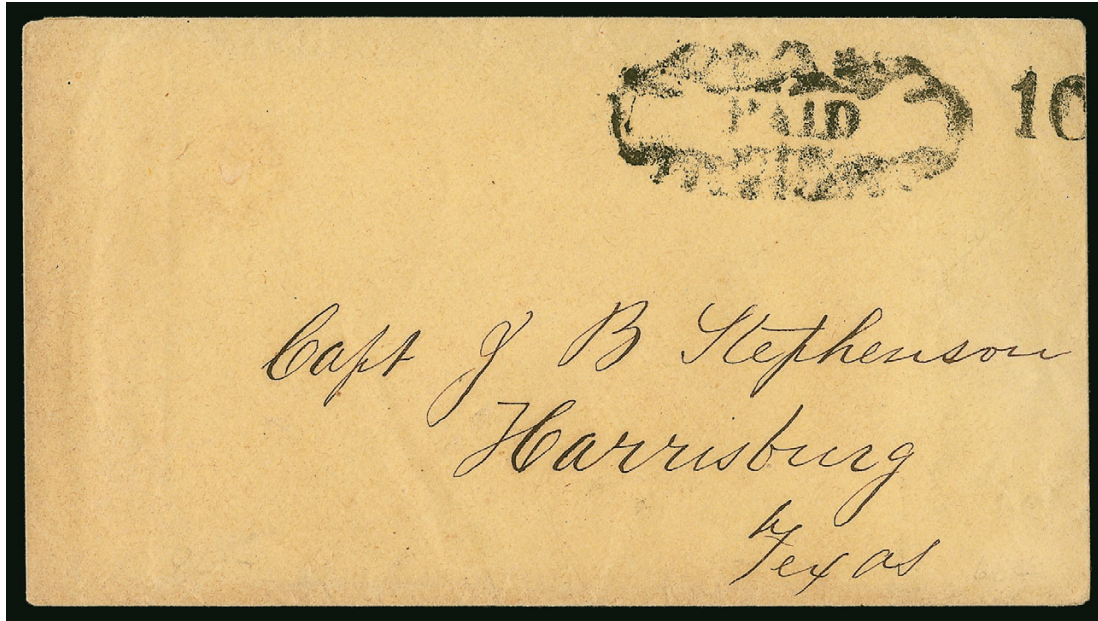

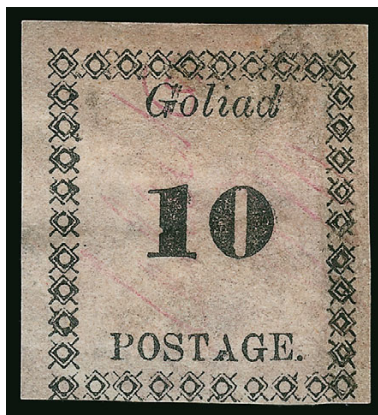

The Confederate postmaster of Goliad was John (Jno.) A. Clarke, whose name was signed by hand on stamps of the first provisional issue and set in type as part of the setting for the second issue. Clarke also served as Secretary to the Board of Trustees of the Paine Female Institute, which later became Goliad College. Clarke signed an oath of allegiance after the war on January 9, 1866 (an image of the document is available at [www.fold3.com](http://www.fold3.com)).

August Dietz reported that the Goliad provisional stamps and the similar stamps of Helena, Texas, were printed at the offices of the *Goliad Messenger*. The editor of this newspaper was Reverend Alexander F. Cox (his middle initial was incorrectly stated as "M." by Dietz). The publisher was R. W. Peirce.

The Goliad provisionals were printed from typeset forms in denominations of 5c and 10c. The Type I setting, without Clarke's name, was used to print stamps issued prior to the Type II setting, probably in 1861 and 1862. 10c stamps are much scarcer from this earlier period, since the rate was still 5c for distances under 500 miles. The Type II setting was probably made in 1863.

Our census of Goliad provisionals, available at our website at <http://siegelauctions.com/enc/pdf/GoliadTX.pdf>, records two examples of the Goliad on Rose paper. The other, ex Ferrary, Hind, Caspary and Lilly, is on a patriotic cover (may not originate). Two other 10c Type I are known, on Gray paper (Scott 29X4).

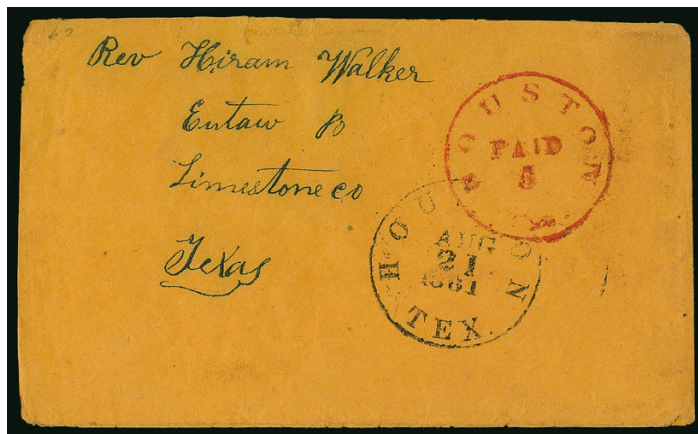

# KNOXVILLE, TENNESSEE, 10-CENT PROVISIONAL ENVELOPES

The discovery of this 10c envelope design, which is similar to the 5c, is discussed in an article by Peter Powell in the Jan.-March 2005 issue of the *Confederate Philatelist*. He quotes the *Redfield Stamp Weekly* of April 30, 1910: "Mr. W.H. Legg has turned up a Knoxville 10 cent red, of the same design as the 5 cent blue. His copy is on white paper and Mr. John Luff, in the course of investigating the specimen, succeeded in discovering a copy of the same stamp on orange." Legg was an early dealer who passed away in 1915. Powell traces ownership to the famous Worthington collection, then to Lichtenstein. The Red on White next appeared at auction in the Caspary sale, and again in the 1987 auction of Scott Gallagher's Tennessee collection. The Red on Orange appeared in the 1933 Hind sale. Mr. Powell successfully united both the unique white paper and orange paper examples for the first time since 1917 when Lichtenstein purchased them as part of the Worthington collection.

The person most likely to be the Macon postmaster who issued the provisional stamps is Dr. Edward L. Strohecker, a graduate of the Medical College of South Carolina, who was elected three times as Macon's mayor. He helped to organize the Georgia Medical Association, and travelled to visit and treat Confederate troops during the war. Another postmaster and possible stamp issuer is Washington Poe, a relative of the poet, who also served a term as mayor and was elected as a Union delegate to the Georgia Secession Convention in Milledgeville.

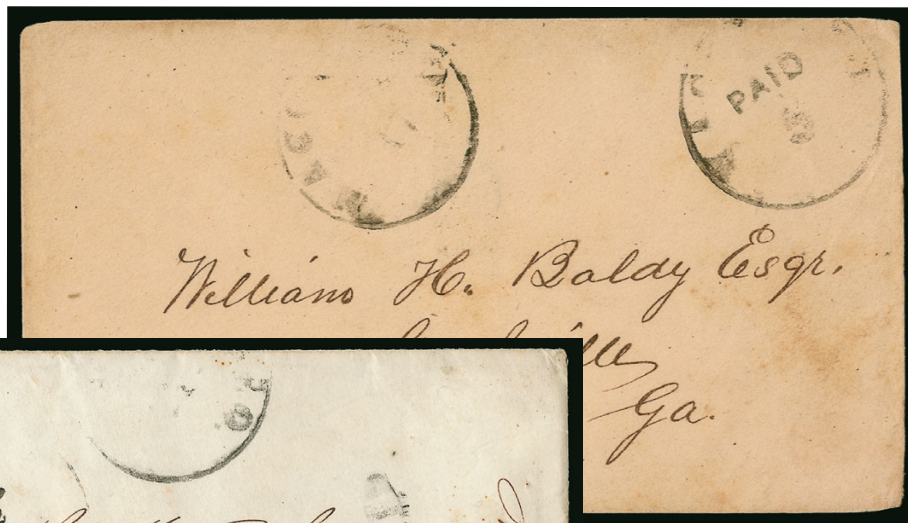
All of the Macon provisional stamps were printed from typeset forms. The 2c and two of the three 5c settings simply state the denomination and nothing else, and they were the first stamps printed. These were followed by the four-line "square" stamp, which includes the words "Post Office" and "Macon, Ga." The order of issue is confused by the Scott Catalogue listings.

James H. Francis was appointed U.S. postmaster of Marion on December 31, 1859, and he was reappointed as Confederate postmaster on July 16, 1861 (Richard L. Calhoun, *The Postmaster Provisionals of Virginia*).

Our records now contain seven covers with the Marion 10c provisional, plus a repaired stamp affixed to the back of a cover noted in the Crown book as part of the Worthington collection. The most recent discovery of a Marion provisional occurred in March 2000 when a nearly complete cover surfaced in an auction of the R. G. Hunter estate in Virginia (sold in our 2000 Rarities sale, Sale 824, lot 443). In addition to the seven stamps on covers, there are two unused singles (the one offered here and the other ex Ferrary) and perhaps one or two off-cover singles.

James P. Johnson was appointed U.S. postmaster of Pittsylvania Court House (known as Chatham today) by President James Buchanan on January 20, 1859. He was appointed C.S.A. postmaster on July 29, 1861 (Richard L. Calhoun, *The Confederate Postmaster Provisionals of Virginia*). During his term as postmaster Johnson issued a 5c Red provisional adhesive stamp bearing his name. The typeset design is nearly identical to the Danville typeset provisional, and Danville's postmaster, William D. Coleman, stated that his stamps were printed at the offices of the *Democratic Appeal*. For this reason philatelists assume that the same printer produced both postmasters' stamps, substituting one name for the other. The Pittsylvania Court House stamps were printed on wove and laid papers. Dangerous counterfeits on wove paper were made from type and borders that closely resemble the originals, and these are often counted in census work. The count of genuine examples currently (and correctly) stands at 10 on Wove (66X1) and 3 on Laid (66X2).

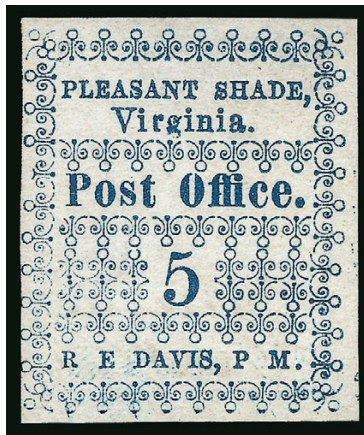

The tiny town of Pleasant Shade had a population of 57 in 1860. Robert E. Davis was appointed U.S. postmaster by President James Buchanan on January 11, 1860. He was appointed C.S.A. postmaster on July 27, 1861, and was replaced by Eugene W. Spratley on July 14, 1863 (Richard L. Calhoun, *The Confederate Postmaster Provisionals of Virginia*). Postmaster Davis had his provisional stamps printed at Andrew F. Crutchfield & Company, publisher of the local Petersburg newspaper, *The Daily Express*. This was the firm that printed the nearly identical Petersburg provisionals. Crutchfield & Co. used five of the settings from the Petersburg form, substituting the names of the post office and postmaster, and printing the Pleasant Shade stamps in blue instead of red.

The Calhoun census published in *The Confederate Postmaster Provisionals of Virginia*, which accords with our own, records a total of 22 stamps, including an unused block of six, an unused vertical pair, seven unused singles, a used single off cover, a used single on piece, three singles on covers and one pair on cover.

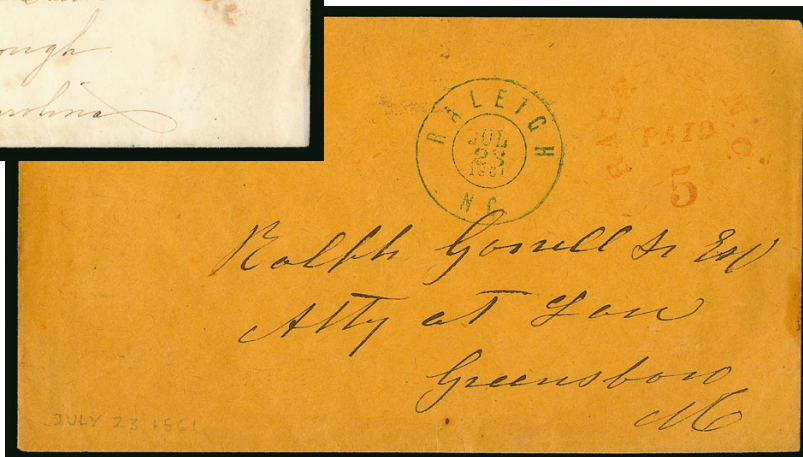

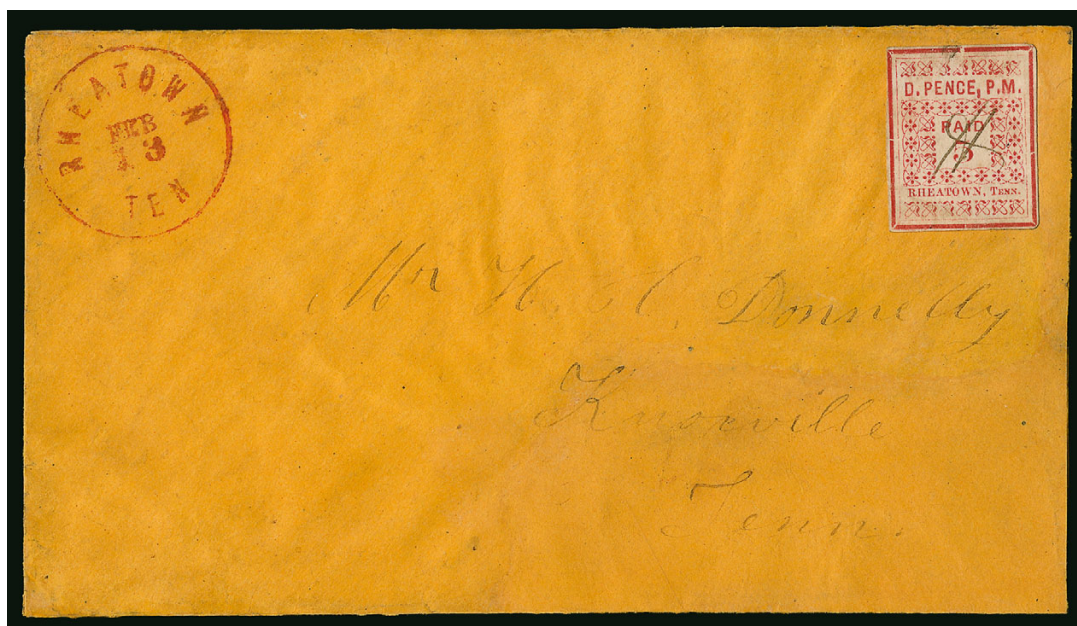

The 5c provisional stamps issued by Postmaster D. Pence were printed by the same printer who produced the Tellico Plains Tenn. provisional. An affidavit by the Tellico Plains postmaster, M.F. Johnson, dated March 24, 1876, states that his stamps were printed in Knoxville by "Hawes Lea." The June dates recorded for the Rheatown suggest that it came first, and the postmaster's own recollections place the issue in "midsummer 1861" (see Crown book, p. 307). Although dated examples show use into April 1862, a relatively long period of time, the issue is extremely rare.

The same basic type form containing three subjects was used for the Rheatown and Tellico Plains Tenn. provisionals. For the Rheatown, all three were 5c denominations. The inside border at the top of each stamp is made up of seven ornaments; the unique arrangement of the ornaments in each subject enables philatelists to identify the position of any stamp.

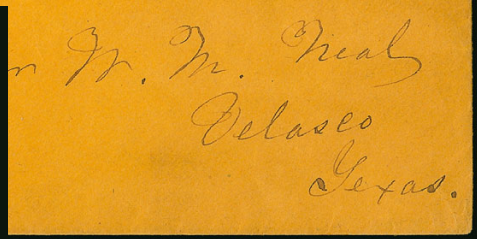
Our records contain at least a half-dozen off-cover examples the Rheatown 5c, including an unused pair, the only known multiple. Our previous census included the item offered here as on the upper half of a cover. The six covers we record are as follows (in chronological order, type identified):

- 5) Feb. 15 (1862), Ty. I, cover to David Cleage, circular datestamp struck twice, ex Caspary
- 6) Apr. 9 (1862), Ty. II, cover to Mrs. Wm. Brown, ex MacBride, Dr. Graves, Boshwit and Dr. Brandon (Siegel Sale 1073, lot 329, realized \$15,000 hammer).

The other has a significant thin spot.

This was originally the lefthand stamp in a pair discovered by Earl Weatherly. Weatherly sold the pair to Earl Antrim, who put his usual green rubber handstamp on back, which unfortunately bled through to the front. The bleeding was far worse on the righthand stamp. The pair was separated by noted dealer Jack Molesworth and it received a 1965 P.F. certificate stating "Genuine, with some original gum and a stain". The "stain" was caused by the handstamp, which has since been professionally removed. The stamp has a 2010 P.F. certificate as "Genuine, unused, with small part o.g."

The Mississippi River and inland waterway routes were essential lifelines within the Confederacy. Early in the war, Federal naval strategy focused on control of the Mississippi, and, by the spring of 1862, key port cities were captured by Federal forces, giving them control of the river. With the Southern states divided between East and West, the Confederate government was forced to devise special measures to maintain transportation and communication along the trans-Mississippi routes. Surreptitious traffic across the river was carried on by private and government couriers, and the post office was authorized to appoint agents to ensure that the mail lines remained open. In April 1863 the Confederate Congress authorized a "preferred mail" across the Mississippi River and established a 50c rate per half-ounce. The act was revised to create an "express mail" without a fixed rate of postage, but instead limited to no more than a dollar per half ounce. By October 1863, Postmaster General Reagan secured a contract to have mail carried across the Mississippi at the rate of 40c per half ounce. Meridian and Brandon, Mississippi, were chosen as the eastern terminal points. Shreveport and Alexandria, Louisiana, were chosen as the western terminal points. This is the earliest recorded use of the "express mail" service.

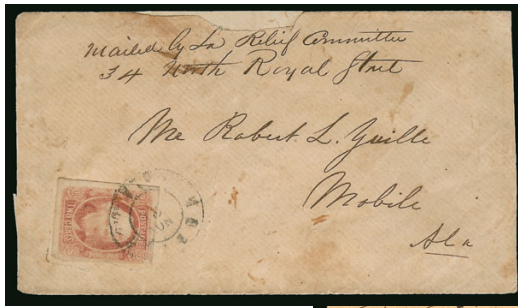

VERY FINE. A RARE EXAMPLE OF MAIL SENT TO A CONFEDERATE DOCTOR IN THE NAVY, WHICH WAS FORWARDED BY THE LOUISIANA RELIEF COMMITTEE. THIS IS THE ONLY RECORDED EXAMPLE OF AN EASTBOUND TRANS-MISSISSIPPI RELIEF COMMITTEE USE.

On May 31, 1863, a group of expatriate New Orleans citizens in Mobile, Alabama, organized a committee to alleviate the suffering of poor citizens who remained in U.S.-occupied New Orleans, Louisiana. With the tacit concurrence of Federal authorities in New Orleans, they arranged shipments of food and clothing to New Orleans and helped citizens leave New Orleans for the Confederate States. These "Louisiana Relief Committee at Mobile" trips between Mobile and New Orleans via Pascagoula ran along the Mississippi Sound and carried letters which were not sanctioned by the U.S. Jules Denis, C.S.A. provost marshal at Mobile, examined the southbound letters. The U.S. also used these trips to transmit P.O.W. flag-of-truce mail to and from prisoners in New Orleans. The latest known Louisiana Relief Committee cover was postmarked in Mobile on September 2, 1864.

The Committee also handled the forwarding of mail addressed to C.S.A. military personnel in Mobile. This type of mail typically did not originate in New Orleans, and is considerably rarer. In addition, since it did not cross the lines, it was not censored by the provost marshal at Mobile. The Committee apparently paid the C.S.A. postage on these letters as a favor to the senders, including the 2¢ C.S.A. drop letter rate on mail addressed to Mobile. The Committee undoubtedly carried mail from Mobile to New Orleans, but none has been identified. Apparently for security reasons, the Committee did not endorse westbound letters, and they would have no postal markings since they were hand-carried all the way to New Orleans addressees.

Despite an overwhelming advantage in force against a small Confederate garrison, the Federals suffered a humiliating defeat in the battle at Sabine Pass on September 8, 1863. Two gunboats were grounded and surrendered — the U.S.S. *Sachem* and the *Clifton*, and captured men were moved to prisons at Houston, Hempstead (Camp Groce) and Tyler (Camp Ford). Based on the fewer than ten known covers from prisoners captured at Sabine Pass, it appears that they were moved between these locations over a period of six months. The endorsements, postmark dates and censor markings help identify mail from these prisons. In this case, the February New Orleans datestamp and endorsements point to the prison at Houston. Harrison records only three covers from the Houston Prison.
